Hello SECAFEST '25 Participant!

We are gearing up for another great SECAFEST Celebration on **Sunday, July 13th, 2025** from 4 to 9:30 pm on the grounds of Memorial Park in Quarryville.

SECAFEST is our annual summer celebration of food, games and fun for everyone, along with an amazing fireworks display to end the evening! In past years we have had inflatables, pony rides, games, food trucks, crafters, vendors, and informative booths. We hope that you will join us in making this year's celebration better than ever by sponsoring our event OR agreeing to be a vendor at our event!

Being a SECAFEST sponsor is a fantastic way to get your message out and promote your business! By helping to sponsor our event, we would like to help your business as well! See pages 6 & 7 for more information on sponsorship opportunities.

Vendor Agreements (pages 3 to 5) will be accepted on a first-come, first-served basis. We are looking to provide a wide variety of foods, merchandise, and games for family fun. We reserve the right to approve all applications. The deadline to register is Saturday, June 28th, 2025. You must return your agreement with payment by that date to reserve your space. SECA is not responsible for any items lost in the mail! You can bring your paperwork directly to our office if you choose located at 299 Park Avenue, Quarryville, PA 17566. The office is typically open from 9am to 3pm, Monday through Friday, but please call ahead in case we are out conducting other SECA business.

The rental fee is \$25 for profit vendors and \$15 for non-profit organizations for the first 10 x 10 space. Each additional space is \$10. Rental fee for food truck/trailer is \$60. Electrical hookup is available for an additional \$40.

Quarryville Borough requires vendors to display a vendor permit. Apply at the Quarryville Borough Office, 300 St. Catherine Street, Quarryville; 717-786-2404. The permits are \$30 and good for 90 days. The Borough will waive the fee if the vendor donates a portion of money back to SECA.

The event set up is from 1:30pm - 3:30pm and every vendor will have a designated area. Parking for one vehicle is allowed at each space. Plan to park and stay for the entire event. There is no route for in and out traffic. Additional vehicles are encouraged to park in the public lots around the park.

The fireworks go off at 9:30 pm, so the crowd stays around all evening. We hope that you will come to celebrate with us and help make this a super fun event for our community!

The **Southern End Community Association/SECA** (Sponsor) and the individual, organization or business (Vendor) described in Article 1 below, agree that subject to the terms and conditions of this Agreement, Vendor shall sell and/or exhibit only the products, services, and information specified and approved in Article 1 at **SECAFEST 2025**, a festival which the Sponsor coordinates in Quarryville, PA on Sunday, July 13th, 2025 from 4 pm to 9:30 pm.

Article 2: Terms and Conditions

1. This agreement must be completed and signed by Vendor and returned to Sponsor no later than July 5th, 2025, with the appropriate fees and shall not be in effect until accepted and signed by Sponsor.
2. Vendor agrees to abide by the rules and regulations for SECAFEST 2025 and any changes thereto shall be provided to Vendor prior to the start of the event.
3. Vendor agrees to sell only those products listed and approved by Sponsor on page 3 of this agreement.
4. The vendor is responsible for supplying its own personnel, tables, chairs, signs, etc. and for maintaining all liability insurance and any other insurance that may be necessary.
5. The vendor is responsible for breaking down all trash/boxes resulting from booth set-up and operation. You may place trash in the dumpster located by the SECA building or trash cans placed throughout the event. (Do not place any set up trash in the public trash receptacles in the park.)
6. The sponsor is not responsible for Vendor's property.
7. Vendor agrees to indemnify and hold Sponsor, Sponsor's officers, volunteers, and anyone associated with Sponsor harmless from any and all loss or damage to Vendor, Vendor's employees, or another person on Vendor's property attributable to any act or omission of Vendor or Sponsor.
8. Vendor agrees to abide by all Borough, State and Federal laws applicable to it and its activities at SECAFEST 2025.
9. This event will be held Rain or Shine, and it is the Vendor's responsibility to be fully prepared for inclement weather.
10. In the event of inclement weather your vendor fees and/or sponsorship donations will be a donation to SECA To create recreational opportunities for residents of Southern Lancaster County by providing high value programs for children and adults.

Article 3: Termination

Sponsor reserves the absolute right to terminate the Agreement in the event the vendor sells or attempts to sell any product or service other than those specified in Article 1 or breaches any of the regulations for SECAFEST 2025. In the event the Sponsor terminates the Agreement, Vendor shall immediately cease any activities at SECAFEST 2025 and remove all equipment, personnel and other property from the venue and forfeit all fees paid to Sponsor.

Article 4: Fees

- Each additional 10 ft x 10ft space: \$15 each
- Food Trailers: \$60
- Electric Service: \$40

All funds for space must accompany this agreement.

Cancellations:

- Prior to 30 days before event: Full refund
- 30 to 20 days prior to event: 50% refund
- 19 days or less prior to event: No refund
